AGE LIMIT & ELIGIBILITY CRITERIA:

1. Upper age limit is relaxable by 5 years for the candidates belonging to SC, ST, VJNT, SBC & OBC (Should possess caste certificate & caste validity certificate issued by Competent Authority of Government of Maharashtra) wherever the post is reserved for that category of backward class.
2. The condition of upper age limit is not applicable to the departmental employees working in CIDCO.
3. Date of birth shall be as per the School Leaving Certificate and completed age as on **31st May 2015** should be mentioned.
4. The experience as on **31st May 2015** should be mentioned. For Driver Operator, experience from the date of passing SSC exam will be considered.
5. 5% reservation is applicable for Project Affected Person (PAP).
6. The Upper Age Limit for Project Affected Persons (PAP) will be relaxed upto **45 years** including caste reservations as per G.R. dated 03.02.2007. PAP certificate should be issued by Competent Authority of Government of Maharashtra.
7. In case of candidates clearing the online examination and other things being equal, preference will be given to CIDCO Project Affected Persons.

RESERVATION CRITERIA:

1. Maharashtra State Public Services (Reservation for Schedule Castes, Schedule Tribes, Denotified Tribes (Vimukta Jatis), Nomadic Tribes, Special Backward Class and Other Backward Classes) Act 2001 has been enforced by the Govt. of Maharashtra from 29th January, 2004. As per the provisions under Sub-section 2 (ii) of Section-4 of this Act, the principle of Creamy-Layer has been made applicable to all categories except Schedule Castes and Scheduled Tribes i.e. VJNT, SBC & OBC category.
2. Candidates claiming the benefit of reservation under SC, ST, VJNT, SBC & OBC categories, should produce a caste certificate at the time of interview. They will also enclose an attested copy of caste validity certificate issued by the Caste Scrutiny Committee if available with them at the time of interview. However, the candidate who applied without submitting Caste Validity Certificate, if selected, an appointment order will be issued to him/her as per the provisions / directives prescribed in G.R. of Govt. of Maharashtra vide No. BCC-2011/Pra.Kra.1064/2011/16-B dated 12.12.2011.
3. In case of VJNT category, if candidate belonging to particular VJNT category for which post is advertised is not available then the said post will be filled in from the other VJNT category as per the interchangeability norms.
4. For claiming the benefit of caste reservation, candidates should submit attested copy of Caste Certificate, Caste Validity (If available) and Certificate of Domicile

of Govt. of Maharashtra issued by the appropriate Authority of Govt. of Maharashtra at the time of interview.

5. The caste certificate issued by appropriate Competent Authority of Maharashtra State only will be considered as valid for availing the benefit of reservation including application fees.
6. Backward class candidates should be domicile of Maharashtra State and should be of the categories notified by the Maharashtra State viz (a) Scheduled castes (including SC category person who has adopted Baudha Religion) (b) Scheduled Tribes (c) VJNT Special Backward Class and (e) Other Backward Class.
7. Once the caste is notified in application form, it cannot be changed at any stage later on.
8. The Backward Class candidates who apply against Open category will not be permitted to change the option once exercised at any stage later on.

1. The candidates belonging to VJNT, SBC and OBC categories and belonging to Creamy Layer or those backward class candidates who do not possess the caste certificate & Domicile Certificate issued by the appropriate Competent Authority of Maharashtra State should apply as Open category candidates for all purposes & they shall pay the application fees applicable to open category candidates.
2. Where there is no reservation for any specific category / community of backward classes, in such case candidates of that category/community should apply as open category candidates & they will have to pay the application fees as applicable to open category candidates.

Bank Transaction charges, if any, for Online Payment of application fees/intimation charges will have to be borne by the candidate.

GENERAL INSTRUCTIONS:

1. Online exams shall be conducted tentatively during **17th July 2015 to 02nd August 2015** across various centers in Navi Mumbai, Thane & Mumbai.
(Date of examination shall be intimated later)

2. Candidates will have to invariably produce and submit the requisite documents such as valid call letter, stipulated original identity proof, a photocopy of photo-identity proof etc. at the time of examination and proficiency test respectively.
3. Before applying for the mentioned posts, the candidate should ensure that he/she fulfils the eligibility and other norms mentioned in this advertisement. Candidates are therefore to carefully read these instructions/ guidelines and follow all the instructions given for submitting online application. In case, candidate is short listed for proficiency test, he/she will have to fulfill the physical requirements as per the norms mentioned in the advertisement, else will be liable to be rejected and proficiency test will not be conducted.

IDENTITY VERIFICATION

In the examination hall as well as at the time of interview, the call letter along with the original and a photocopy of the candidate's photo identity (bearing the same name as it appears on the call letter) such as PAN Card/ Passport/ Driving Licence/ Voter's Card/ Bank Passbook with photograph/ Photo identity proof issued by a Gazetted Officer/ People's Representative along with a photograph / Identity Card issued by a recognised college/ university/ Aadhar card with a

photograph/ Employee ID should be submitted to the invigilator for verification. The candidate's identity will be verified with respect to his/her details on the call letter, in the Attendance List and requisite documents submitted. If identity of the candidate is in doubt the candidate may not be allowed to appear for the Examination/ interview.

Ration Card and E-Aadhar card will not be accepted as valid id proof for this process.

Note: Candidates have to produce, in original, the same photo identity proof bearing the name as it appears on the online application form/ call letter and submit photocopy of the same along with Examination call letter as well as the Interview Call Letter while attending the examination/ interview, without which they will not be allowed to appear in the examination/ interview.

Candidates reporting late i.e. after the reporting time specified on the call letter for Examination will not be permitted to take the examination. The reporting time mentioned on the call letter will be prior to the Start time of the test. A. APPLICATION REGISTRATION

I. IMPORTANT POINTS TO BE NOTED BEFORE REGISTRATION

Before applying online, candidates should

- i. Scan their photograph and signature ensuring that both the photograph and signature adhere to the required specifications as given under Guideline for photograph & signature scan and upload.
- ii. Have a valid personal email ID and mobile no., which should be kept active till the completion of this Recruitment Process. CIDCO may send call letters for the Interview etc. through the registered e-mail ID. In case a candidate does not have a valid personal e-mail ID, he should create his/her new e-mail ID and mobile no. before applying on-line and must maintain that email account and mobile number.

II. APPLICATION PROCEDURE

1. Candidates have to go to the CIDCO's website www.cidco.maharashtra.gov.in and go to 'careers' and click on the option "**APPLY ONLINE**" which will open a new screen.
2. To register application, choose the tab "**CLICK HERE FOR NEW REGISTRATION**" and enter Name, Contact details and Email-id. A Provisional Registration Number and Password will be generated by the system and displayed on the screen. Candidate should note down the Provisional Registration Number and Password. An Email & SMS indicating the Provisional Registration number and Password will also be sent.
3. In case the candidate is unable to complete the application form in one go, he can save the data already entered by choosing "**SAVE AND NEXT**" tab. Prior to submission of the online application, candidates are advised to use the "SAVE AND NEXT" facility to verify the details in the online application form and modify the same if required. Visually Impaired candidates should fill the application form carefully and verify/ get the details verified to ensure that the same are correct, prior to final submission.
4. Candidates are advised to carefully fill and verify the details filled in the online application themselves as no change will be possible/ entertained after clicking the "**FINAL SUBMIT**" BUTTON.

5. The Name of the candidate and his Father should be spelt correctly in the application as it appears in the Certificates/ Mark sheets. Any change/alteration found may disqualify the candidature.
6. Validate your details and Save your application by clicking the '**VALIDATE YOUR DETAILS**' and '**SAVE & NEXT**' button.
7. Candidates can proceed to upload Photo & Signature as per the specifications given in the Guidelines for Scanning and Upload of Photograph and Signature detailed under point "C" given below.
8. Candidates can proceed to fill other details of the Application Form.

B. PAYMENT OF FEES ONLINE MODE

1. The application form is integrated with the payment gateway and the payment process can be completed by following the instructions.
2. The payment can be made by using only Debit Cards (Rupay/ Visa/ Master) , Credit cards , Internet Banking , IMPS, Cash Cards/ Mobile Wallets – Vodafone MPesa, Airtel Money, Oxicash, Mobikwik, Paycash etc.
3. After submitting your payment information in the online application form, *PLEASE WAIT FOR THE INTIMATION FROM THE SERVER. DO NOT PRESS BACK OR REFRESH BUTTON IN ORDER TO AVOID DOUBLE CHARGE*
4. On successful completion of the transaction, **an e-Receipt** will be generated.
5. Non-generation of 'E-Receipt' indicates PAYMENT FAILURE. On failure of payment, Candidates are advised to login **again** using their Provisional Registration Number and Password and repeat the process of payment.
6. Candidates are required **to take a printout of the e-Receipt** and online Application Form. **Please note that if the same cannot be generated, online transaction may not have been successful.**

C. GUIDELINES FOR PHOTOGRAPH & SIGNATURE SCAN AND UPLOAD

- In case the face in the photograph or signature is unclear, the application may be rejected. Candidate may edit the application and re-upload the photograph/ signature in such case.

PHOTOGRAPH IMAGE

- Photograph must be a recent passport size colour picture.
- The picture should be in colour, against a light-coloured, preferably white background. Look straight at the camera with a relaxed face.
- If the picture is taken on a sunny day, have the sun behind you, or place yourself in the shade, so that you are not squinting and there are no harsh shadows.
- If you have to use flash, ensure there's no "red-eye".
- If you wear glasses make sure that there are no reflections and your eyes can be clearly seen.
- Caps, hats and dark glasses are not acceptable. Religious headwear is allowed but it must not cover your face.
- Dimensions 200 x 230 pixels (preferred).
- Size of file should be between 20kb-50kb.
- Ensure that the size of the scanned image is not more than 50KB. If the size of the file is more than 50KB, then adjust the settings of the scanner such as the DPI resolution, no. of colours etc., during the process of scanning.

SIGNATURE IMAGE

- The applicant has to sign on white paper with Black Ink pen.
- The signature must be signed only by the applicant and not by any other person.
- The signature will be used to put on the Attendance sheet.
- The Applicant's signature obtained on the call letter and attendance sheet at the time of examination should match the uploaded signature. In case of mismatch, the candidate may be disqualified.

- Dimensions 140 x 60 pixels (preferred).
- Size of file should be between 10kb —20kb.
- Ensure that the size of the scanned image is not more than 20KB.

SCANNING THE PHOTOGRAPH & SIGNATURE

- Set the scanner resolution to a minimum of 200 dpi (dots per inch).
- Set Color to 'True Color'.
- File Size as specified above.
- Crop the image in the scanner to the edge of the photograph/signature, then use the upload editor to crop the image to the final size (as specified above).
- The image file should be JPG or JPEG format. An example file name is: image01 .jpg or image01 .jpeg. Image dimensions can be checked by listing the folder files or moving the mouse over the file image icon. Candidates using MS Windows/MS Office can easily obtain photo and signature in .jpeg format not exceeding 50KB & 20KB respectively by using MS Paint or MS Office Picture Manager. If the file size and format are not as prescribed, an error message will be displayed.

While filling in the Online Application Form the candidate will be provided with a link to upload his/her photograph and signature.

Procedure for Uploading the Photograph and Signature

- There will be two separate links for uploading Photograph and Signature.
- Click on the respective link "Upload Photograph / Signature".
- Browse & Select the location where the Scanned Photo/ Signature file has been saved.
- Select the file by clicking on it.
- Click the 'Upload' button

NOTE:

There will be no negative marking.

*The version for online test should be English & Marathi. Level of competency is SSC.

B) PROFICIENCY TEST (Max 80 Marks):-

The Candidates should score at least 45% marks in online test to qualify for Proficiency Test.

Final Merit list will be out of 200 marks (Online exam 120 marks + Proficiency test 80 marks).

Note: The Candidate should score at least 45% marks in online test to qualify for Proficiency Test i.e. candidate's scoring less than 54 marks out of 120 marks in the online exam will not qualify for proficiency test.

Proficiency Test shall be conducted in manner mentioned below:

Minimum Physical standards:-

- i) Height = minimum 165 cms.
- ii) Weight = minimum 50 kgs.
- iii) Chest = Normal - 81 cms & Expansions- - 86 cms. (Minimum 5 cms. Expansion is essential)
- iv) Eye sight: Normal

Personality and proficiency test/ Interview :- (10 marks)

Personality and proficiency test/ Interview where additional marks shall be allotted for candidates who is having experience of local fire service, industrial fire Service, State level sport certificate, NCC certificate, HMTV driving license, additional qualification as well as on the basis of Personality and proficiency of the candidate.

Selection for the post of Driver Operators:-

After above selection procedure Driver operators has to pass driving test on Heavy motor Vehicle/ Fire Engine under the supervision of RTO authority and Fire Officer, CIDCO. On the basis of their merit list selection of Driver operator will be finalized.

- a) Every member of Selection Committee shall allot marks independently to each candidate and average of total marks given by the members shall be deemed to be the marks secured by the candidate during interview,
- b) The Selection Committee shall thereafter prepare a list of candidates in descending order as per the marks secured by them in written examination and / or average marks in interview and shall place the same in sealed envelope for forwarding it to the Competent Authority/Chief Vigilance Officer, CIDCO.

The selected candidate has to undergo medical test and fitness certificate has to be obtained from Chief Health Officer, CIDCO or Government Hospital as decided by CIDCO management.

Final Merit list will be out of 200 marks (Online exam 120 marks + Proficiency test 80 marks).
